- 4. Replace throw-away filter for clean permanent type.
- 5. Inspect system for gas leaks.
- 6. Check calibration of controls and adjust if necessary.
- 7. Tune system operation to maximum efficiency.

SPRING COOLING CHECKOUT: (Call for appointment)

- 1. Clean evaporator and condenser coils.
- 2. Replace throw-away filter or clean permanent type.
- 3. Test for refrigerant leaks.
